The initial random selection consisted of one (1) BMD and one (1) VBM batch numbers.

Additional Contests Selection: One (1) additional batch number was selected for contests that were not represented in the initial random selection. The batch selected consisted of vote at polls ballots.

Ballot Type: Optical Scan

Contest Type: Single winner (Vote for one candidate or Yes or No for measure); and multi-winners (Vote for more than one)
