Supplemental petitions must be filed prior to the close of the nomination period. (E. C. §§ 8061 and 8106)

Filing fees shall be paid at the time the candidate obtains nomination forms from the county elections official. (E. C. §§ 8105 and 8106(b)(3))

		During this period, candidates for congressional office may submit a statement for inclusion in the sample ballot. The statement shall not exceed 250 words and the estimated fee must be submitted by this date. (E. C. § 13307.5)

Candidates will be notified within 4 calendar days of filing the petition of any deficiency. Candidate may then, prior to the close of the nomination period, submit a supplemental petition or pay the pro rata portion of the filing fee to make up the deficiency. (E. C. §§ 8061, 8105 and 8106)

FEB. 9 (Th) E-54 5:00 P.M.		NOMINATION DOCUMENTS TO SECRETARY OF STATE Last day to file nomination documents with Secretary of State. (E.C. § 10704) POLITICAL PARTY ENDORSEMENT Last day for any qualified political party to submit to the county elections official a list of all candidates for voter-nominated office who have been endorsed by the party. The county elections official shall print any such list that is timely received from the state party chairperson in the sample ballot. (§ 13302(b))

PUBLIC EXAMINATION PERIOD FOR CANDIDATE STATEMENTS/CANDIDATE NAMES AND BALLOT DESIGNATIONS During this period, candidate statements, candidate names, and ballot designations shall be open for public examination. A fee may be charged to any person obtaining a copy of the material. Any person may challenge the aforementioned candidate information by filing a petition for writ of mandate no later than February 15. (E. C. § 13313 and 13314)

If no candidate receives a majority of votes cast at the special primary election, the names of the top two vote getters shall be placed on the special general election ballot. (E.C.§10706)
