Summary	Copy Winners
Description	<p>This use case allows Staff to copy winners from an election to a new election. The copy winners' function is typically performed in a General Election. Majority of the General Election's contests and candidates derive from the Primary Election. The top two candidates (winners), along with the contest information, are copied to the General Election during the Copy Winners process. This function eliminates double data entry. Once the Primary Election has been certified by the Secretary of State and the final results have been imported into ECBMS, the system calculates and marks the winners. Once the winners have been identified, the Operator imports the winners into the newly created General Election, an election must be created before the copy winners process can occur. The import process copies candidate and office table information except the information pertaining to forms and petitions. During the copy process, the system automatically marks the copied candidates and contests as On Ballot and Protected, which eliminates candidates from going through the audit process again.</p>
