Description	For various reasons, potential voters will be flagged and thus their voter record will be marked as Fatal Pending.

Precondition	<ul style="list-style-type: none"> Staff has appropriate user access rights to the system. Staff has logged into the system to Fatally Pend a voter. Voter Record must exist in system with an Active or Inactive status.
ExpectedResult	<ol style="list-style-type: none"> The potential voter's record has been updated to reflect Fatal Pend status. The potential voter's record has been added to the que for notice generation.
DetailedProcessFlow	<ol style="list-style-type: none"> The User makes selection to search for Voter (See Use Case Search for Voter) The User selects Voter Record. The User selects the option to change Pend Code to a Voter Record. <ol style="list-style-type: none"> The system shall allow User to change Pend Code and Reason Code to Voter Record.
